


# How to Register for eDossier Access (Students and Advisors)

## 1. Go directly to [this registration page](https://www.formularydecisions.com/individual-registration) on the FormularyDecisions website.



## 2. You should be taken to this screen:





- A. **If you participated in last year's P&T Competition**, select "Yes." As a pop-up screen will indicate, you will be redirected to a page that asks you to update your account for the current competition, using your existing login credentials.





- B. If you did *not* participate in last year's P&T Competition, select "No" to begin the registration process. You will be taken to this screen, asking whether you are registering as a judge:

You will be taken to the screen shown below.




When you select "Next," you are taken to a data entry screen.

**3. Most of the information requested on the data entry screen is self-explanatory. However, please pay special attention to these fields.**

- A. As indicated, you **must** register using a **school-provided email address** (i.e., a “.edu” address). The email address must be a specific, verifiable address tied to a single person (i.e., not something like [studentAMCP@college.edu](mailto:studentAMCP@college.edu)).
  
- B. You **must** select a pharmacy school/college from a drop-down list.


**If your school does not appear on this list**, your school has not visited the P&T Competition online portal to register its intention to compete (or it registered after the early access deadline). **Schools must register their intention to compete** before anyone associated with the school will be granted access to the eDossier site.

- C. You must specify your role in the P&T Competition.

Select “Student” if you are competing on a P&T Competition team, serving as the Competition Coordinator, or have another official student role. **Be prepared to enter your AMCP Student Member # in the field that will appear.**



Other options are “P&T Competition Advisor” and “Other” (e.g., mentor). Advisors are **not** required to enter an AMCP member #. Anyone who selects the “Other” option must provide some explanatory text regarding their role.

- D. If you make any errors or do anything the system doesn’t like, you will get an error message (likely at the top of the page):



#### 4. When you have entered all information successfully and hit “Next,” you should see this screen:




**Note that every person’s credentials must be verified** to ensure appropriate access to confidential information. Expect that process to **take 1-3 business days**.


#### 5. After your credentials have been verified, you should receive the confirmation email message that looks like this:




The message asks you to click on a link to activate your account.




When you click on the link, you will be taken to a screen that looks like this:



6. After you click on the “Click here to login” link and enter your user name and password, you should be taken to the FormularyDecisions home page for the P&T Competition, with immediate access to the eDossier.



You also should receive an email message from “support@FormularyDecisions.com” that looks like this:
