## **How to Register for eDossier Access**

- 1. Go to the FormularyDecisions website at <u>https://www.formularydecisions.com/global/dynamic.aspx</u>.
- 2. Scroll to the bottom of the page to find this option for "P&T Competition Participants":



3. After you click on the "Register today!" button, you will be taken to this screen:



A. **If you participated in last year's P&T Competition**, select "Yes." As a pop-up screen will indicate, you will be redirected to a page that enables you to update your account for the current competition, using your existing login credentials.



- B. If you did <u>not</u> participate in last year's P&T Competition, select "No" to begin the registration process.
- 4. If you select "No" in Step 3, you will be taken to this screen:

When you select "Next," you are taken to a data entry screen.

- 5. Most of the information requested on the data entry screen is self-explanatory. However, please pay special attention to these fields.
  - A. You **must** select a pharmacy school/college from a drop-down list. (Judges should select the school for which they will serve as a judge.)

If your school does not appear on this list, your school has not created an account in the P&T Competition portal and registered its intention to compete. These steps *must* be completed before individuals will be granted access to the eDossier site.



B. You must specify your role in the P&T Competition.

Select "Student" if you are competing on a P&T Competition team, serving as the Competition Coordinator, or have another official student role. **Be prepared to enter your AMCP member # in the indicated field.** 

Other options are "P&T Competition Advisor" and "Local or National Judge."

If none of these options is applicable, select "Other" and provide some explanatory text.
